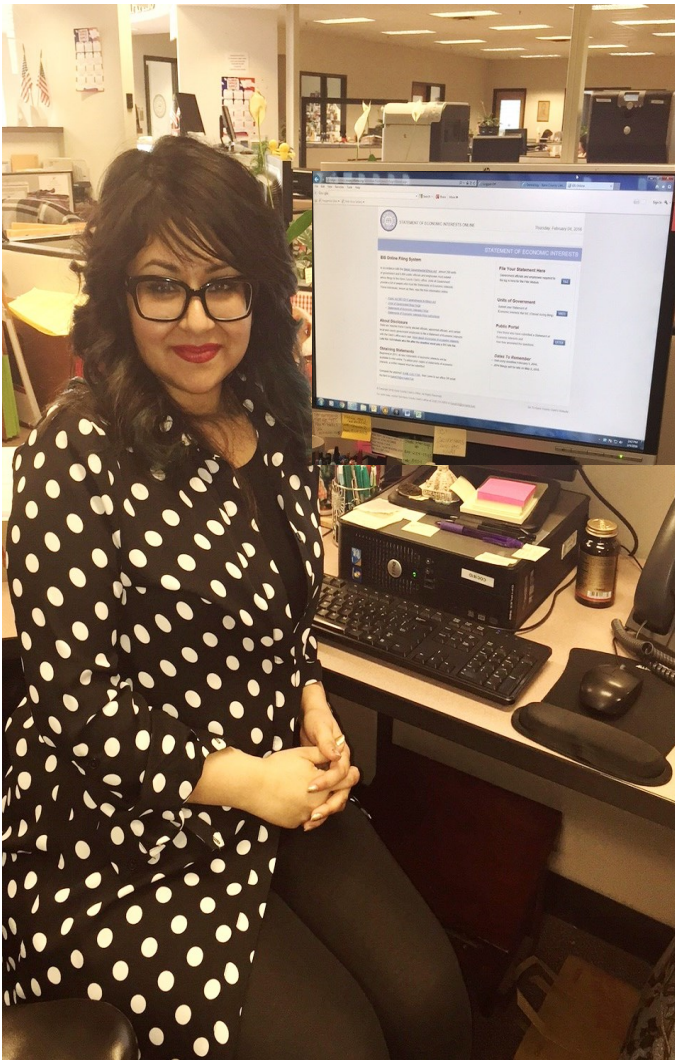

For the 2016 Economic Interest Statement Filing, all 151 Units of Government have submitted their lists of persons required to file.

Electronic notifications will be sent to each filer at the end of March at which time they can file their Statement of Economic Interest online at: <https://kaneis.countyofkane.org/SEIOnline/SEI/Login.aspx>

For those filers who did not provide an email address, a paper Statement of Economic Interest will be sent to their home and they can return it to the Kane County Clerk's Office in person or by mail.

All Statements are due by Monday, May 2nd, 2016 and any statements filed after this due date will be assessed a \$15 late filing fee (per Illinois State Statute 5 ILCS 420/1-101). ## GENERAL PRIMARY - MARCH 15, 2016

### ARE YOU REGISTERED TO VOTE?

Kane County residents (excluding City of Aurora residents) can verify their voter registration by visiting the Kane County Clerk's website at <http://kanecountyelections.org>.

In order to verify your voter registration you will need three pieces of information— Last Name; House Number; and Street Name. The lookup system will display your voter registration information including Registration Status, Precinct, Polling Place, Voting Districts, and Sample Ballot.

If you find that you are not registered or you would like to update your information, please contact the County Clerk's Election Department at **(630) 232-5990**. We can help you update your voter registration information and if you are not registered to vote we can help you get registered.

**The Illinois State Board of Elections offers online voter registration on their website at: [www.elections.il.gov](http://www.elections.il.gov). February 16th is the last day to utilize this online registration before the General Primary.**
